EXECUTIVE ORDER OF A

DECLARATION OF A LOCAL STATE OF EMERGENCY

Pursuant to Section 24 of the Executive Law

PLEASE TAKE NOTICE, THAT EFFECTIVE 6:00 P.M. EDT, OCTOBER 12, 2025 THE HONORABLE HUGH O'BRIEN, MAYOR OF THE VILLAGE OF SALTAIRE, HEREBY DECLARES A LOCAL STATE OF EMERGENCY IN THE VILLAGE OF SALTAIRE DUE TO THE IMPACTS OF RAIN AND WIND FROM THE NOR'EASTER WHICH IS CURRENTLY PREDICTED TO LAST THROUGH AT LEAST THE MORNING OF OCTOBER 14, 2025, AND THE RESULTING TERMINATION OF FERRY SERVICE TO THE VILLAGE, THAT THE PUBLIC WOULD BE IMPERILED BY ANY TRAVEL TO OR AROUND THE VILLAGE, THEREBY RESULTING IN THIS DECLARATION OF A LOCAL STATE OF EMERGENCY; IT IS THEREFORE:

ORDERED THAT AS THE MAYOR AND CHIEF EXECUTIVE OF THE VILLAGE OF SALTAIRE, DUE TO THE SEVERE WEATHER RESULTING IN THE CESSATION OF THE FERRY SERVICE TO THE VILLAGE, PURSUANT TO THE POWERS PERMITTED BY SECTION 24 OF THE NEW YORK STATE EXECUTIVE LAW, AS OF 6:00 P.M. ON OCTOBER 12, 2025, A LOCAL STATE OF EMERGENCY IS IN EFFECT IN THE VILLAGE OF SALTAIRE, AND THAT THE CLERK OF THE VILLAGE OF SALTAIRE SHALL NOTIFY THE OFFICIALS OF THE VILLAGE AND PUBLIC AS SOON AS PRACTICABLE OF THIS DECLARATION AND ORDER,

THIS ORDER SHALL BE EFFECTIVE AT 6:00 P.M. ON OCTOBER 12, 2025, THE TIME OF ITS DECLARATION BY THE HONORABLE MAYOR HUGH O'BRIEN. PLEASE TAKE FURTHER NOTICE THAT THIS ORDER SHALL BE IN EFFECT FOR A PERIOD OF FORTY-EIGHT HOURS OR UNTIL FUTHER NOTICE.

PLEASE TAKE FURTHER NOTICE THAT ANY VIOLATION OF THIS EMERGENCY ORDER OR OF ANY ORDER ISSUED HEREUNDER IS A CLASS B MISDEMEANOR, WHICH MAY BE PROSECUTED BY THE VILLAGE TO THE FULL EXTENT OF THE LAW.
