

LOCAL LAW NO. OF 2022 OF THE VILLAGE OF SALTAIRE A LOCAL
LAW MODIFYING SECTION 1 OF CHAPTER 5 (ANIMALS) OF THE SALTAIRE
VILLAGE CODE

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE
INCORPORATED VILLAGE OF SALTAIRE AS FOLLOWS:

Section 1.0 Title, Enactment, Effective Date and Purpose.

1.1. Title.

This Local Law shall be entitled, "Local Law No. of 2022: A Local
Law Modifying Section 1 (A) (4) of Chapter 5 Animals of the Saltaire
Village Code".

1.2 Enactment.

Pursuant to Section 10 of the Home Rule Law, the Village Law and the
Village Code of the Incorporated Village of Saltaire, the Incorporated Village of
Saltaire, County of Suffolk and State of New York, hereby enacts by this Local
Law No. of 2022, a Local Law of the Incorporated Village of Saltaire.

1.3. Effective Date.

This local law shall take effect on the filing of the approved Local Law
with the Secretary of State of New York, which shall be within twenty (20) days
after its approval by the Board of Trustees of the Incorporated Village of Saltaire.

1.4. Purpose and Intent of Local Law.

A. The purpose and intent of this local law is to adopt regulations which will provide for and ensure the safety of the residents, guests and visitors of the Village of Saltaire by the adoption of this Local Law containing those regulations pursuant to Article 10 of the New York State Village Law.

1.5 Findings.

The Board of Trustees hereby finds:

A. Allowing residents to bring their dogs on the ocean front may enhance the experience of dog ownership for its residents, but only if it can be done and during times when the beaches are not populated with bathers or beachgoers and when it does not interfere with the operation of the beach by any Village staff.

2.0 General Provisions.

2.1 Section 1 (A) (4) of Chapter 5 of the Saltaire Village Code is hereby created to read as follows:

§ 5-1. General restrictions on dogs.

A. [Amended 5-31-1980 by L.L. No. 1, 1980; 7-15-1983 by L.L. No. 1, 1983; 4-21-1990 by L.L. No. 3, -1990; by L.L. No. 10, 2022] At no time shall any person owning or having charge or custody of a dog suffer or permit it to:

(4). Enter and remain upon the ocean beach from May 1 through September 30, inclusive, except between the hours of 6:00 p.m. and 9:00 a.m., and except in areas where lifeguards have established a protected swimming area or other Village activities are in progress.

3.0 Severability and Validity

3.1 In the event that any portion or section of this Local Law may be determined to be invalid, the remaining portions and sections of this Local Law shall remain in full force and effect.
